Attached please find the second quarter report for Transient Occupancy Tax (TOT) revenue collected.

The total TOT collections through the second quarter of the fiscal year 23/24 are \$3,896,992.25. This equates to 62.85% of the budgeted revenue of \$6,200,000.00 for the 23/24 fiscal year.

The Treasurer-Tax Collector's Office is responsible for the administration and collection of transient occupancy tax (TOT) for establishments located in the unincorporated areas of the County.
